WHEREAS, Jonathan's commitment to better himself will continue after high school as he plans to attend Roane State Community College to study mass communications prior to attending Middle Tennessee State University to study video and film production; and


WHEREAS, it is appropriate that we should pause to recognize Jonathan Whaley as one of the most outstanding young people in our state; now, therefore,
