Her career in the medical field started at Baptist Hospital, and she eventually worked at Park West Hospital, from which she retired; and

WHEREAS, a woman of faith, Janie Amburn is a devout member of Crossroads Church of the Nazarene; she has served the ministry in numerous capacities, including as a Sunday School teacher, a teen counselor, and a church pianist, a position she held for more than forty years; and

WHEREAS, her many accomplishments aside, Janie Amburn will always be most grateful for the companionship she shared with her husband, the late Floyd Amburn. After beginning their courtship in the late 1970s, the couple eventually married and settled in Loudon; and

WHEREAS, throughout her life, Janie Amburn has enlightened and enriched the lives of all she has encountered, whether it was as a foster parent, a church member, or a surgical technician; and

WHEREAS, countless citizens from the State of Tennessee and beyond have undoubtedly had their lives changed for the better because of Mrs. Amburn, and it is appropriate that the members of this General Assembly recognize her commendable efforts; now, therefore,
