WHEREAS, Maggie Kulback is a member of the finance board and the steering committee at Immaculate Conception Church; she is a past school board president of Immaculate Conception School and currently chairs the school's annual funds drive; and

WHEREAS, a member of the APSU Tower Club and Gobs Club, Mrs. Kulback is past chair of the Candlelight Ball and past co-chair of the homecoming committee and the 2010 capital campaign; she also served on the selection committee for president Alisa White; and

WHEREAS, Maggie Kulback is grateful for the love and companionship she shares with her husband, Barry, with whom she has contributed to APSU for thirty-six consecutive years; as a result of a major gift pledge during the 2010 Legacy Capital Campaign, APSU recognized the couple by naming Kulback Atrium in the Maynard Mathematics and Computer Science Building in their honor; and

WHEREAS, Mrs. Kulback is an exemplary citizen whose commitment to helping others is representative of the very best characteristics of the good people of the Volunteer State, and she should be specially recognized; now, therefore,
