It also provides recordings for the blind, supports the county shepherd fund, and sends eyeglasses to mission fields with missionaries; and

WHEREAS, desiring to foster the future of Tennessee's youth, the Parsons Lions Club also contributes to the Boy Scouts and Cub Scouts, the Tennessee School for the Blind, and the Tennessee River Agriculture Expo's youth programs; and

WHEREAS, reflecting the club's dedication to public service and civic duties, members Ed Townsend, Fred Alexander, Tony Martin, and Ray Murphy all previously served as district governors for the state; and

WHEREAS, the membership of this venerable organization has undoubtedly benefited from the stellar knowledge and steadfast leadership from its eighty-year chairperson and longest acting member, Cleo Rhodes, and its 2018 acting president, Steve Glass; and

WHEREAS, for these noble efforts, it is most appropriate that the members of this General Assembly recognize the Parsons Lions Club and join its members in celebrating this impressive milestone of eighty years of community outreach; now, therefore,
