A RESOLUTION to recognize and commend Representative Kevin Brooks for his honorable and astute service to the people of Tennessee as a member of the House of Representatives.

WHEREAS, it is most appropriate that the members of this body should honor those fellow legislators who have performed their duties with the utmost integrity and whose efforts during their time in office have been dedicated to providing thoughtful and exemplary service to their districts and to this great state; and

WHEREAS, Representative Kevin Brooks of Cleveland is one such distinguished public servant, who has served both his constituency and this legislative body with honor and ability; and

WHEREAS, Kevin Brooks has distinguished himself as a public-spirited citizen of the highest order and as an exceptional asset to the good people of Bradley County as a member of the 105th, 106th, 107th, 108th, 109th, and 110th General Assemblies, representing House District 24; and

WHEREAS, Kevin Brooks received a Bachelor of Arts degree from Lee University and worked as both Assistant to the President and Director of Alumni Relations at his alma mater; he has worked in public relations and conference management in the Department of Communications for the Church of God since 2004; and

WHEREAS, Representative Brooks is a highly influential figure in the political, social, and civic lives of Bradley County, having served with distinction as a Cleveland City Planning commissioner, chairman of the Blue Ribbon Advisory Council for Cleveland City Schools, division chair for United Way of Bradley County, a board member of Main Street Cleveland, and an officer and board member of the Rotary Club of Cleveland; and

WHEREAS, he has also served on the Board of Directors of Operation Compassion (2010–2016) and the State Board of Directors of Habitat for Humanity (2015) and as a member of the Tennessee Hospitality Association, Rejuvenate Advisory Board, Orlando Client Advisory Board, Nashville Convention and Visitors Corp. Advisory Board, and Religious Conference Management Association; and

WHEREAS, as an active and dynamic participant in the legislative process during his time in the General Assembly, Representative Brooks has rendered sterling service as a member of the House Employee Affairs Subcommittee, House Domestic Affairs Subcommittee, House Consumer and Employee Affairs Committee, House Children and Family Affairs Committee, House Higher Education Subcommittee, House Domestic Relations Subcommittee, House Rules Committee, House Finance, Ways and Means Committee, House Education Committee, House General Subcommittee of Education, House General Subcommittee of Children and Family Affairs, House General Subcommittee of Finance, Ways and Means, House Ethics Committee, House Education Administration and Planning Committee, House Calendar and Rules, and House Insurance and Banking; and

WHEREAS, Representative Brooks also served with distinction as vice chairman of the House Republican Caucus during the 106th General Assembly, assistant majority leader during
