## HOUSE JOINT RESOLUTION NO. 1092

A RESOLUTION to confirm the appointment of Kim H. White to the board of trustees of the University of Tennessee.

WHEREAS, Tennessee Code Annotated, Section 49-9-201, as amended by Chapter \_\_\_ of the Public Acts of 2018 (SB2260), provides for the governance of the University of Tennessee by the board of trustees; and

WHEREAS, Tennessee Code Annotated, Section 49-9-202, as amended by Chapter \_\_\_ of the Public Acts of 2018 (SB2260), provides that the governor shall appoint ten (10) members to the board of trustees of the University of Tennessee; and

WHEREAS, Governor Bill Haslam has appointed Kim H. White of Chattanooga to the board of trustees of the University of Tennessee to a term that commences July 1, 2018, and expires June 30, 2022; and

WHEREAS, Ms. White is president and chief executive officer of River City Company, an organization focused on the economic development of downtown Chattanooga; and

WHEREAS, Ms. White has prior executive and board of directors experience in telecommunications and real estate and through numerous community organizations in Chattanooga; and

WHEREAS, Ms. White earned a bachelor's degree from the University of Tennessee at Chattanooga; and


WHEREAS, Ms. White has remained involved with the university as past president of the UTC Alumni Board, Chancellor's Roundtable, and UC Foundation, was honored with the University of Tennessee at Chattanooga's 2015 Outstanding Service Award, and will bring valuable contributions as a member of the board of trustees; and

WHEREAS, Tennessee Code Annotated, Section 49-9-202, as amended, provides that each member appointed by the governor to the board of trustees of the University of Tennessee shall be confirmed by the General Assembly; now, therefore,

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE ONE HUNDRED TENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE SENATE CONCURRING, that this body does hereby confirm the appointment of Kim H. White to the board of trustees of the University of Tennessee for a term that commences July 1, 2018, and expires June 30, 2022.
