WHEREAS, Raymond Doyle Gaines was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, Mr. Gaines served with acumen and alacrity as a teacher at Macon County High School, in which position he earned the respect and admiration of his colleagues and students for the exemplary quality of his work; he taught biology and physical education, coached boys and girls basketball, and served as assistant football coach; and

WHEREAS, in 1990, Mr. Gaines was elected Macon County Executive and served with distinction in that position until embarking upon his retirement in 2002; and

WHEREAS, an avid historian, Doyle Gaines researched the Korean War to assist the Macon County Historical Society with an upcoming book; he also compiled stories about World War II from Tennessee veterans and collaborated with the Historical Society to publish *Macon County Veterans of World War II*; and

WHEREAS, Mr. Gaines was deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Doyle Gaines enjoyed the loving companionship of his wife, Shirley, and was the proud father of four children: David (Kathy) Gaines, Dale (Ronnie) Reid, Dawn (Paul) Thompson, and Diana (David) Hernandez; and

WHEREAS, Doyle Gaines leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, it is fitting that the members of this General Assembly should pause to remember the bountiful life of this exceptional public servant and human being; now, therefore,
