WHEREAS, he is survived and remembered fondly by his wife, Peggy Coe; children, Ken Coe, Becky Ginn, and Beth Coe; grandchildren, Meredith Ginn, Drew Ginn, and Abby Ginn; sister, Joyce Huddleston; and numerous nieces and nephews; and

WHEREAS, William Coe leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and
