WHEREAS, a gentleman of many talents, Mr. Golden has been a volunteer member of the State Republican Executive Committee since 2007, representing the 27th State Senate District, and he also attended the 2008 and 2012 Republican National Conventions as a member of the Tennessee delegation; and

WHEREAS, he was honored as the Madison County Republican Party Man of the Year in 2010; and

WHEREAS, Scott Golden received a Bachelor of Science degree in Political Science from Lambuth University and a Master of Arts degree in Political Science from the University of Rhode Island; and
