A RESOLUTION to recognize and honor Marlin Haston upon the occasion of his retirement from the Board of Directors of Cumberland County Banks.

WHEREAS, he began his long career with Farm Bureau when he became the general agent and agency manager for Tennessee Farmers Insurance Company in Cumberland County in 1959; and

WHEREAS, in addition to his long and fruitful tenure with Farm Bureau, Mr. Haston has been a member of the Board of Directors of Cumberland County Banks since April 1, 1965, and it is from this esteemed entity that he is taking his much-deserved retirement, after more than half a century of devoted service; and

WHEREAS, throughout life's challenges and successes, Marlin Haston has enjoyed the love and support of his family: his wife, Imogene Walker Haston, and their three children, Jean Ann Hall, Jerry Haston, and David Haston. Jean Ann and David have followed in their father's footsteps, as the former is a farmer and the latter is a Farm Bureau Insurance agent; and

WHEREAS, Marlin Haston is a good farmer and a great supporter of the agricultural and banking communities in Tennessee; now, therefore,
