WHEREAS, no finer such organization can be found than that of the Clarksville Association for Down Syndrome, a group whose exemplary mission is to educate and create a supportive network for individuals with Down syndrome, their families, and their community; and

WHEREAS, Down syndrome is a genetic condition in which structural changes to the brain cause delays in the development of communication, cognitive abilities, and motor skills; and


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
