A RESOLUTION to commend Chief Danny Humphrey of the Norris Police and Volunteer Fire Department for his honorable and astute service to the people of Tennessee on the occasion of his retirement.

WHEREAS, it is the privilege of this General Assembly to honor those exemplary public servants who have dedicated their careers to protecting and serving the citizens of this State; and

WHEREAS, Chief Danny Humphrey is one such individual, who has served with distinction as director of public safety of the Norris Police and Volunteer Fire Department and who will soon embark upon a much-deserved retirement from a distinguished career in law enforcement that has spanned thirty-nine years; and

WHEREAS, a graduate of Norris High School, Chief Danny Humphrey will remain in Norris after his retirement; he intends to spend his newfound free time relaxing and joining the morning coffee crowd at Sweet Café; and

WHEREAS, Chief Humphrey dedicated nearly four decades of his life to serving the good people of Norris; his efforts and leadership were instrumental in making Norris one of the safest communities in this State; and

WHEREAS, Chief Danny Humphrey truly epitomizes the ideal of the dedicated law enforcement officer who is wholly committed to the highest tenets of public service, and he should be specially recognized; now, therefore,


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
