WHEREAS, Danny Moore was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, born and raised in Crockett County, Danny Moore founded Moore Pumps in 1984 with just \$780, a rusty pickup truck, and a hunger to be successful; and

WHEREAS, under Mr. Moore's leadership, Moore Pumps has grown into one of the largest full-service hydraulic repair facilities in the Southeast, selling pumps in all fifty states and sixty-five foreign countries; the company repairs hydraulic pumps for the U.S. Navy, and every aircraft carrier in the Navy fleet has at least one Moore pump onboard; and

BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mr. Moore.


