WHEREAS, Mrs. Collins is known as an excellent seamstress, often sewing clothes, including wedding dresses and band uniforms, for her grandchildren and others; and

WHEREAS, a courageous woman, Mrs. Collins has been a survivor of breast cancer since 1995; she is the recipient of two knee replacements and one hip replacement; and

WHEREAS, an agricultural entrepreneur, Mrs. Collins has engaged in organic farming since 1968, having tended vegetable and flower gardens for fifty years; she has orchestrated the family's annual canning of jams, jellies, pickles, vegetables, and relishes since her marriage to Mr. Collins in 1947; and

WHEREAS, as she approaches her tenth decade, Elinor Collins remains an active and productive member of society, participating in various civic and community events as her health permits; and

WHEREAS, we wish to grasp this golden opportunity to specially recognize one of Tennessee's most outstanding citizens on this very special occasion; now, therefore,


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
