WHEREAS, Ms. Penny returned to the Office of the Comptroller in 2001 as a legislative auditor; since 2010 she has held the position of legislative and policy coordinator; and

WHEREAS, during her tenure in the Comptroller's Office, Ms. Penny has been an integral part of the office and a vital confidante to Comptroller Justin P. Wilson on legislative and policy analysis as well as other governmental issues; and

WHEREAS, she has been instrumental in creating innovative legislative tracking programs and helping to establish a rapid response system to respond to legislative inquiries; and

WHEREAS, Linda Penny's remarkable success as a public servant and civic leader is directly attributable to her reliance on the time-honored values of hard work and common sense and her uncommon ability to work well with people from all walks of life; and

WHEREAS, Ms. Penny is a person of impeccable morals and irreproachable integrity, and she has worked with purpose and conviction to establish a brighter future for the good people of Tennessee; and

WHEREAS, Linda Penny has also worked tirelessly for her church, Belle Meade United Methodist Church, and is an essential part of its worship committee; and

WHEREAS, her many accomplishments aside, Linda Penny is fortunate to share both love and companionship with her husband, William L. Penny, their son and daughter-in-law, Martin and Katie, and their granddaughter, Emerson; and


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
