A RESOLUTION to honor the memory of Kathleen Starnes of Nashville.

WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of Kathleen Marie Starnes; and

WHEREAS, Kathleen Starnes was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens in numerous capacities; and

WHEREAS, Mrs. Starnes served with acumen and alacrity as owner of Southern Scientific, a medical supply store, in which position she earned the respect of her peers and customers alike for the exemplary quality of her work; and

WHEREAS, an advocate for victims of crimes, Kathleen Starnes visited prisons and spoke publicly about her own experience as a rape survivor; in addition, she served on numerous nonprofit boards, including Tennessee Voices for Victims, which she served as president; and

WHEREAS, she is survived by her husband, Larry Maxwell; daughter, Abby (Jason) Maxwell-Dodson; two granddaughters, Hannah and Norah; brother, Rick Starnes; nieces, Hallie, Bailie, and Audrie Starnes; nephew, Grant; and great-niece, Adaleigh; and

WHEREAS, Kathleen Starnes leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all her chosen endeavors; and

BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mrs. Starnes.


