WHEREAS, Ms. Eaton's passion, determination, and resolve have been invaluable to the success of The Family Center and to improving the lives of the many families it serves; and

WHEREAS, believing strongly that parents need tools to better understand their children and resources to cope with stress, Dawn Eaton has moved The Family Center to the forefront of changing the way the community deals with the prevention of child abuse and neglect; and

WHEREAS, her knowledge, insight, and persistence have been vital in convincing governmental and private entities of the long-term negative effects associated with adverse childhood experiences; and

WHEREAS, during her seven-year tenure at The Family Center, Ms. Eaton has increased the annual budget from \$600,000 to more than \$1.1 million and brought its finances into balance; and

WHEREAS, throughout her career, Ms. Eaton has demonstrated the utmost professionalism, ability, and integrity, winning the respect and admiration of her colleagues and clients alike; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED TENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we extend to Dawn F. 
BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
