WHEREAS, a man of faith, Mr. Collins is a member of Hartsville Pike Church of Christ, where he regularly coordinates mission trips and church camps that are enjoyed by all in his community; and

WHEREAS, a parade was conducted in January 2018 to honor David Collins and his LifeChanger of the Year nomination, a testament to how truly treasured and beloved he is to his community; and

WHEREAS, Mr. Collins is an inspiration to his colleagues and students, both past and present, and his friendship and counsel are highly valued by those who are fortunate to know him; and

WHEREAS, David Collins truly epitomizes the ideal of the dedicated teacher who is wholly committed to the highest precepts of public service and quality education for all, and he should be specially recognized; now, therefore,


