## **SENATE JOINT RESOLUTION NO. 620**

WHEREAS, recent projects of the Zeta Chapter include the Spotlight on an Educator program, which brings the Zeta members together to honor one of their own and fulfill her wish list of needed classroom items; and

WHEREAS, the Zeta Chapter performs a number of other charitable endeavors throughout the year, including making scarves and pillows for cancer patients, walker caddies for nursing homes, "feelie quilts" for Alzheimer centers, quilts for Children's Hospital, and gift bags for the Ronald McDonald House. Zeta members also volunteer in classrooms, register children for the Imagination Library at Boo at the Zoo, wrap gifts for the Angel Tree, and provide assistance with the Festival of Reading; and

WHEREAS, the members of the Zeta Chapter are part of a genuine sisterhood, not only committed to their noble mission of academic excellence but also to each of their fellow members; and




BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
