WHEREAS, she has always had a love of quilting, having participated in quilting groups at three different churches simultaneously; and

WHEREAS, Myrna Clodfelter Davis continues to spend as much time as possible each year on the family farm in Stanley County, North Carolina, working with her cousins and visiting with her many North Carolina friends and relatives; and


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
