WHEREAS, Mr. Kelley was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, born in Harriman on November 25, 1954, Stephen L. Kelley was the son of Ruth Allion Kelley and the late George Kelley; he attended Roane County High School and served in the United States Navy for three years; and

WHEREAS, he is survived by his wife, Renee Rickard Kelley; his three sons, Will Kelley, Sam Kelley, and Ben Kelley; his mother, Ruth Kelley; his brother, David Kelley; his sisters, Becky Brown, Janet Kelley, Jean West, and Laura Ousley; and a host of nieces, nephews, and cousins; and

BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mr. Kelley.


