## SENATE JOINT RESOLUTION NO. 756

A RESOLUTION to recognize Jimmy Moore on the occasion of his retirement.

WHEREAS, Jimmy Moore is one such estimable person, and after serving with distinction for thirty-eight years as a certified registered nurse anesthetist at Cookeville Regional Medical Center (CRMC), he has taken a much-deserved retirement; and

WHEREAS, Mr. Moore began his work at CRMC as an orderly in 1967. After graduating from Tennessee Technological University with a chemistry degree, he pursued his registered nursing degree from the University of Tennessee at Nashville and furthered his education at The Ohio State University; and

WHEREAS, Jimmy Moore began his career as a certified registered nurse anesthetist on October 3, 1979, and his first case was a transurethral resection of the prostate; and

WHEREAS, Mr. Moore's career in medicine continued a proud family tradition, in which his father, Dr. J.T. Moore, Jr., practiced medicine for forty-eight years in the Upper Cumberland; his grandfather, Dr. J.T. Moore, Sr., practiced medicine with a horse and buggy from 1899 to 1951; his brother, Dr. Lee Moore, works as a urologist at CRMC; and his nephew, Dr. Jeff Moore, is a general surgeon also at CRMC; and

WHEREAS, Jimmy Moore exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout his estimable career, Mr. Moore has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of both his patients and his colleagues; now, therefore,


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
