CONCURRING, that we extend to Barbara Gray our heartfelt wishes for a happy and fulfilling retirement and every continued success in her future endeavors.


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
