WHEREAS, one such noteworthy person is Una Coffman, who has been named an honoree of the Founders' Day Celebration in Roane County in recognition of her many contributions as a productive and compassionate citizen of Roane County; and

WHEREAS, the daughter of Fred J. and Dorothy M. Wright, Mrs. Coffman was born on May 2, 1940, in Harriman; and

WHEREAS, a 1958 graduate of South Harriman High School, Una Coffman received her Bachelor of Science degree in Education from the University of Tennessee, Knoxville in 1962; and

WHEREAS, after teaching at Midway High School and serving as a social worker for Roane County, Mrs. Coffman spent more than twenty years as a medical social worker at Harriman City Hospital, where she was named Employee of the Year in 1982; and

WHEREAS, with a desire to help others and get women involved in Roane County government, Una Coffman sought and won election to the Roane County Commission; the first woman elected to the County Commission, she served her fellow citizens as a County Commissioner from 1990 until 2006 and held the position of Chair of the Commission from 1996 until 2006; and

WHEREAS, she has further served her community as a member of the Board of Directors of the United Way of Roane County and the University of Tennessee National Alumni Association; she has donated her time and talents to the Roane Imagination Library, and, most notably, she has performed more than 500 marriage ceremonies in Roane County; and

WHEREAS, Una Coffman evinces her faith as an active and devout member of Kingston United Methodist Church; and

WHEREAS, devoted to her family, Mrs. Coffman is grateful for the love and companionship she shares with her husband of fifty-five years, Donald E. Coffman, her children, Lisa Coffman and Mark Coffman, and her two grandchildren, Jenna Borzellino and Daniel Coffman; and


