WHEREAS, 1965 saw the beginning of Ms. Warmley's five decades of volunteer service at the Harriman Hospital; whether providing an ear to listen or a shoulder to cry on, she found much joy in offering encouragement and hope to others; and

WHEREAS, she has also donated her time and talents to FISH of Roane County, a volunteer group that helps those in need, and United Way of Roane County, which she formerly served as a board member and president; and

WHEREAS, in addition to her passion for volunteer work, Louise Warmley has long harbored a passion for writing; she has been the columnist of "Harriman Happenings" for thirty years, and it is through this venture that she is able to connect with the people of her community, which she greatly enjoys; and

WHEREAS, Louise Warmley is also known as an avid bowler; at one time, she was a member of two bowling leagues. She also attended weekly family community education groups; and

WHEREAS, building on the foundation of faith that was laid early in the home in which she grew up, Ms. Warmley has served faithfully for many years as a member of St. Mary's Baptist Church, where generations of her family have also held membership; and

WHEREAS, having given so much for so many fruitful years to the County of Roane and all her fine neighbors, family, and friends therein, Louise Warmley, as a Roane County Golden Treasure, becomes the latest shimmering jewel added to the county's chest of treasures; and


