A RESOLUTION to honor the memory of George Henry Moore, Jr., of Finger.

WHEREAS, George Moore was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, Mr. Moore was born in Memphis on January 6, 1936, and raised by his parents, Fred and Margaret Ruby Spain; and

WHEREAS, after graduating from Treadwell High School in 1954, George Moore furthered his education by studying computer science at the University of Memphis and later at the University of Maryland; and

WHEREAS, George Moore served with acumen and alacrity as a computer scientist for Computer Scientist Corporation in Tehran, Iran, in which position he earned the respect of his peers and superiors alike for the exemplary quality of his work until he retired in 1979; and

WHEREAS, prior to working with Computer Scientist Corporation, Mr. Moore worked as a computer analyst for the National Institute of Health. After retiring, he bought a farm in Enville and raised pigs and chickens for nearly ten years. He also owned and operated PRN Data Systems in Henderson for five years, until he began a second retirement in 1998; and

WHEREAS, Mr. Moore was also a Shriner, and he helped financially support the organization's work for all of his adult life; and

WHEREAS, a man of faith, George Moore was an active and devout member of the Enville Methodist Church; and

WHEREAS, he was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, George Moore will be fondly remembered by his beloved wife of sixty-two years, Margaret Joyce Hall Moore; his daughters, Vicky Smith, Robbie Rood, Terri Randall, and Staci Fesmire; his grandchildren, Charlie Kinser, Kellie Kinser, Kyle Rood, Kate Lee, and Stan Randall; his great-grandchildren, Gus Kinser, Carter Randall, and Sophie Randall; and his sister, Joyce Marie Spain Bowen; and

WHEREAS, Mr. Moore leaves behind an indelible legacy of integrity and probity in public life, compassion and loyalty in private life, and diligence and dedication in all his chosen endeavors; and

WHEREAS, it is fitting that the members of this legislative body should pause to remember the bountiful life of this exceptional public servant and human being; now, therefore,


