A RESOLUTION to honor and commend Naser Fazlullah of Shelby County.

WHEREAS, it is fitting that we should salute those citizens who, through their extraordinary efforts, have distinguished themselves as community leaders of whom we can all be proud; and

WHEREAS, one such individual is Naser Fazlullah, a highly successful businessman and entrepreneur, who has rendered sterling service to his community during the coronavirus crisis; and

WHEREAS, a compassionate and concerned citizen, he selflessly contributed to his friends and neighbors, distributing more than 2,700 face masks, many in the month of April when face masks were scarce; purchasing more than \$1,200 in groceries for those who were in need; and providing rides to the doctor or the grocery store to many individuals who had no means of transportation; and

WHEREAS, a native of Bangladesh, Mr. Fazlullah earned his Associate of Science degree from Bishop State College and attended the University of South Alabama and the University of Southern Mississippi; and

WHEREAS, he enjoyed a successful corporate career with the Krystal Company, including more than ten years of corporate management and supervisory experience before starting his own small business; and

WHEREAS, a highly respected and admired member of his community, Mr. Fazlullah is a member of the board of directors of the Memphis Oral School for the Deaf and the executive board of the Republican Party of Shelby County, a former vice president of the Northeast Shelby Republican Club, a former vice president and current president of the East Shelby Republican Club, and president of the Republican Cordova Breakfast Club; and

WHEREAS, his many accomplishments aside, Mr. Fazlullah is most appreciative of the love and support of his wife, Shila, and their two sons, Omi and Ohin; and

WHEREAS, Naser Fazlullah epitomizes the spirit and commitment that are characteristic of a true Tennessean, and he should be specially recognized for his many accomplishments and contributions to the State of Tennessee; now, therefore,
