WHEREAS, Gary Gray etched his name in La Follette High School basketball history and the hearts of his fellow teammates and his community at large; his drive and dedication have been displayed throughout his life in everything he has set his mind to; and

WHEREAS, Mr. Gray exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout his estimable career, Gary Gray has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of his colleagues; now, therefore,
