A RESOLUTION to honor the memory of Lucy Lobertini of LaFollette.

WHEREAS, we were greatly saddened to learn of the passing of Lucy Lobertini of LaFollette;

WHEREAS, Lucy Lobertini was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens in numerous capacities;
and

WHEREAS, Lucy Lobertini was a graduate of Lincoln Memorial University and taught English at LaFollette Junior High School. Along with her husband, Leland, she owned and operated Loby Blox in LaFollette; and

WHEREAS, a highly respected member of her community, Lucy Lobertini was the first female Mayor of the City of LaFollette and the first female member of the Campbell County Commission; and

WHEREAS, a staunch member of the Democratic Party, Mrs. Lobertini was serving as a commissioner and secretary of the Campbell County Election Commission at the time of her passing; and

WHEREAS, a lifelong member of LaFollette United Methodist Church, Lucy Lobertini was deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, she was preceded in death by her husband, Leland Lobertini, and her mother, Lorene Wright Irwin; and

WHEREAS, she will be sadly mourned but fondly remembered by her children, Jo Allison Lobertini and husband Paul Mareth; Jeff Lobertini and wife Gwen; Leo Lobertini; and Jennifer Robbins and husband Allan; and

WHEREAS, she is also survived by her grandchildren, Leland Thomas Davidson, Emily Jo Davidson and Greg Rosales, Olivia Lobertini, Corey Phillips, and Logan Phillips; her great-grandchildren, Asher Hensley and Bianca Rosales; her sister, Betty Flatt; her brother, Paris Irwin; her nieces, Regina Irwin and Cara Flatt; and a host of extended family and dear friends; and
