WHEREAS, the members of this legislative body wish to honor the life of Tennessee Department of Correction Correctional Administrator, Debra K. Johnson, who tragically was taken in the line of duty on August 7, 2019; and

WHEREAS, Debra Johnson was a brave and dedicated public servant to the State of Tennessee, having served with the Department of Correction for thirty-eight years; and

WHEREAS, Ms. Johnson began her career with the Department of Correction as a Correctional Officer at the Tennessee Prison for Women in Nashville in 1981. While at the Tennessee Prison for Women, Ms. Johnson held the positions of Corporal, Sergeant, Lieutenant, and Unit Manager; and

WHEREAS, Ms. Johnson was promoted to Deputy Warden of the Tennessee Prison for Women in 2005, and in 2009, she was named the Deputy Warden of the Lois M. DeBerry Special Needs Facility in Nashville; and

WHEREAS, Ms. Johnson was promoted to Warden of the Tennessee Prison for Women in 2011, and in 2013, she was named the Warden of the Turney Center Industrial Complex in Only; and

WHEREAS, Ms. Johnson was promoted to Correctional Administrator in 2016 and most recently directly oversaw the Western Region of the State, which includes the Wardens of the Northwest Correctional Complex in Tiptonville, the West Tennessee State Prison in Henning, the Women's Therapeutic Residential Center in Henning, and the Mark Luttrell Transitional Center in Memphis; and

WHEREAS, a much loved and admired member of the Department of Correction family, Debra Johnson was an experienced and knowledgeable corrections leader who maintained positivity and a supportive nature with her fellow employees and offenders alike; and

WHEREAS, Ms. Johnson was viewed as a mentor and role model by departmental employees and was nominated numerous times for recognition of her outstanding contributions to the Department of Correction; and

WHEREAS, Ms. Johnson was dedicated to her faith as an active and devout member of Fifteenth Avenue Baptist Church in Nashville, where she served for many years; and

WHEREAS, Ms. Johnson was deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, Debra Johnson is survived by her mother, Ms. Annie Porter; her son, Stanley Johnson, Jr.; her daughter, Shernaye Johnson, Ph.D.; her son, Mychal Austin; her
