A RESOLUTION to honor and commend John Edward Berry for his philanthropic efforts.

WHEREAS, during the 2019 holiday season, John Berry will once again headline the Annual Christmas Songs and Stories Tour, now in its twenty-third year, celebrating the true reason for the holiday with concertgoers young and old; and

WHEREAS, no stranger to awards and accolades, John Berry scored a GRAMMY in 1996 for his participation in *Amazing Grace: A Country Salute to Gospel, Vol. 1*; and

WHEREAS, Mr. Berry is committed to giving back to others, both at home and abroad; he donates his time and talents to fundraising events and recently spent ten days in Africa on a mission trip, where he assisted those in need of medical care and basic necessities; and

WHEREAS, he also made a substantial donation to Music Health Alliance from funds that were raised to offset his own medical expenses after being diagnosed with throat cancer; and

WHEREAS, his many professional and philanthropic accomplishments aside, he is most grateful for the love and support he shares with his wife, Robin Ann Berry, and his three children, Taylor Marie, Sean Thomas, and Caelan James; and

WHEREAS, John Berry is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the Volunteer State, and he should be specially recognized; now, therefore,
