WHEREAS, throughout her estimable career, Ms. Freeman demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of the community at large; and

WHEREAS, her many professional accomplishments aside, she is grateful for the love and support she shares with her husband, Michael Meise; and

WHEREAS, Cindy Freeman truly epitomizes the dedicated teacher who is wholly committed to the highest ideals of public service and quality education for all, and she should be specially recognized for her manifold achievements on the occasion of her retirement; now, therefore,
