WHEREAS, in a matter of weeks, volunteers have helped dozens of Germantown residents with everything from removing sheetrock and flooring to donating bottled water and soliciting donations; homeowners in Germantown have been able to reduce their renovation costs thanks to Kristina Garner and her leadership of Germantown Helps; and

WHEREAS, Ms. Garner epitomizes the spirit and commitment that are characteristic of a true Tennessean; and

WHEREAS, the members of this General Assembly find it appropriate to acknowledge and applaud Kristina Garner for her dedication to the State of Tennessee and its citizens; now, therefore,
