### PRIVATE CHAPTER NO. 49

HOUSE BILL NO. 2914

AN ACT to amend Chapter 267 of the Private Acts of 1982; as amended by Chapter 43 of the Private Acts of 2018; and any other acts amendatory thereto, relative to Dickson County.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 267 of the Private Acts of 1982, as amended by Chapter 43 of the Private Acts of 2018, and any other acts amendatory thereto, is amended by deleting from Section 4 the language "County Clerk" wherever it may appear and by substituting instead the language "General Sessions Court Clerk".

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of Dickson County. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For purposes of carrying out any administrative duties and functions necessary to facilitate this act, it shall become effective upon approval in accordance with Section 2. If approved in accordance with Section 2, it shall become effective on September 1, 2020, for all other purposes.
