A RESOLUTION to honor Jim Cain of Nashville, Imperial Potentate of Shriners International.

WHEREAS, Jim Cain of Nashville was elected Imperial Potentate of Shriners International during the 2018 Imperial Session; the highest leadership position within the fraternal organization, the Imperial Potentate serves as president, chairman of the board of directors, and chief executive officer of Shriners International and chairman of the board of directors for Shriners Hospitals for Children; and

WHEREAS, now in his eleventh year as a member of the boards of directors for Shriners International and Shriners Hospitals for Children, Mr. Cain has chaired or been a member of numerous committees and served as the liaison officer to the Boston, Cincinnati, Shreveport, Springfield, and Tampa boards of governors for Shriners Hospitals for Children; and

WHEREAS, a former board member of the Tennessee Railroad Association, he spent three years as state coordinator of Tennessee Operation Lifesaver, Inc., and served as chairman of the board of the organization, as well as its Alabama counterpart; and

WHEREAS, Mr. Cain is indeed fortunate to share love and companionship with his loyal wife of more than fifty years, Patsy; their children, Janice and Jim, Jr.; and their grandchildren, Oakley and Paxton; and

WHEREAS, as Imperial Potentate and a member of the Imperial Divan, Jim Cain has provided outstanding leadership to Shriners International and moved the organization forward in its philanthropic mission of providing expert medical care for children with no financial burden to the patients or their families; now, therefore,
