WHEREAS, Betty Blair Daniel was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens in numerous capacities; and

WHEREAS, a highly respected member of the Kingston Springs community, Mrs. Daniel founded The Ark, a community resource center that provides a number of programs for the residents of South Cheatham County; on January 26, 2020, The Ark will dedicate its new food bank addition in honor of Betty Blair Daniel, who designed, implemented, and oversaw the completion of the food bank; and

WHEREAS, Mrs. Daniel was a passionate advocate for social justice, and she worked ceaselessly to improve the lives of the underprivileged and less fortunate through her work with The Ark and Room in the Inn, in addition to other organizations; and

WHEREAS, she attended five colleges in her lifetime, Vanderbilt University, Boston University, Tulane University, the University of Mississippi, and Trevecca Nazarene University, and earned multiple degrees, including a Master of Business Administration and a Master of Education; and

WHEREAS, Mrs. Daniel was deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, she will be lovingly remembered by her husband of thirty-three years, John Paul Daniel; her brothers, Jack Allen and Ralph Allen; her sister, Mary Gardner Thurman; and a host of family members and friends; and

WHEREAS, she was preceded in death by her parents, Mary Eda Larsen Allen and John Clarence Allen, Jr.; her maternal grandparents, Dr. Ralph Michael Larsen and Vee Larsen; her paternal grandparents, Nell Gardner Allen Lake and John Clarence Allen; her paternal step-grandfather, John Caldwell Lake; her aunts, Bebe Larsen Hogue and Michael Larsen Anderson; and her cousin, William J.
