She has served as a volunteer ambassador for the Make-A-Wish Foundation; a volunteer at St. Jude Children's Research Hospital; a lector, sacristan, and Eucharistic Minister at St. Louis Church; president of the Dominican Associates; and coordinator and founder of the St. Patrick Christmas Outreach and the St. Dominic Environmental Club; and

WHEREAS, Libba Nance exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout her estimable career, Ms. Nance demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of her colleagues and students; now, therefore,
