HOUSE JOINT RESOLUTION NO. 1087

A RESOLUTION to honor and commend Representative Bill Dunn for his honorable and astute service to the people of Tennessee as a member of the House of Representatives.

WHEREAS, it is most appropriate that the members of this General Assembly should honor those fellow legislators who performed their duties with the utmost integrity and whose efforts during their time in office were dedicated to providing thoughtful and exemplary service to their districts and to this great State; and

WHEREAS, the executive vice president of QualPro, Bill Dunn obtained his Bachelor of Science degree in Animal Science and a Master of Science degree in Extension Education from the University of Tennessee; and

WHEREAS, a gentleman who truly appreciates the responsibilities, as well as the privileges, of leadership and citizenship, he has donated his time and energies as a member of the Halls Business and Professional Association, the Fountain City Business and Professional Association, the Powell Business and Professional Association, Tennessee Right to Life, the Fountain City Republican Club, the Powell Republican Club, and the Halls Republican Club; and

WHEREAS, throughout his outstanding career as a legislator, Bill Dunn has worked tirelessly on behalf of his constituents, bringing to his office an honorable bearing and the traditional values of hard work and common sense; and
