A RESOLUTION to honor the Greeneville Woman's Club on the occasion of its 50th Annual Holiday Bazaar.

WHEREAS, it is our pleasure to recognize those estimable Tennessee organizations that are wholly devoted to serving their communities; and

WHEREAS, one such organization is the Greeneville Woman's Club, which is celebrating its 50th Annual Holiday Bazaar this year; and

WHEREAS, organized in 1962, the Greeneville Woman's Club is a group of thirty women who are vitally interested and involved in their community and meet the second Thursday of each month; and

WHEREAS, a 501(c)(3) organization, the Greeneville Woman's Club seeks to raise funds for a variety of service programs to benefit their community in such areas as Arts and Culture, Civic Engagement and Outreach, Education and Libraries, Environment, and Health and Wellness; and

WHEREAS, their biggest annual fundraiser, the 50th Anniversary Holiday Bazaar, will take place on November 7–8, 2020, at Hal Hernard Elementary School in Greeneville. Over the past forty-nine years, the Greeneville Woman's Club has donated around \$1,000,000 raised from its bazaars; and

WHEREAS, last year, the Greeneville Woman's Club expended a total of 11,975 volunteer hours on 279 projects and programs while donating \$56,346 to a variety of worthy causes in their community; and

WHEREAS, this year, this esteemed organization is having a gift bonanza, giving people in the community the opportunity to make a donation and become eligible to win a number of prizes. The members feel that this is a good way to promote local business and provide for the fundraiser to still take place in the event of a cancellation due to COVID-19; and

WHEREAS, this distinguished organization has supported theatre camps for children at the Niswonger Performing Arts Center, bought books and offered activities for children at the Greeneville-Greene County Library, picked up liter along a one-mile area in downtown Greeneville, and held events for those in assisted living facilities; and

WHEREAS, the Greeneville Woman's Club has also provided support to the Boys and Girls Club, the Humane Society, the March of Dimes, Relay for Life, and the Veterans Park; and
