A RESOLUTION to honor and congratulate James Edward Clemons on the celebration of his ninetieth birthday.

WHEREAS, James Edward Clemons will celebrate his ninetieth birthday on February 2, 2019, a milestone that will be commemorated as yet another precious souvenir of life's rich pageant; and

WHEREAS, the son of James Michael Clemons and Hallie Mai Huff Clemons, James Clemons was born and raised in Granville with his brother, Jess, and his sister, Minnie Lena; he graduated from Smith County High School in 1948; and

WHEREAS, Mr. Clemons was raised in Granville United Methodist Church, where he served for fifteen years as superintendent of Sunday school and was a lay leader for many years; in 1967, after moving to Carthage, he became a member of Carthage United Methodist Church, where he has served on the church council and as an usher; and

WHEREAS, in 1948, James Clemons was joined in marriage with Tommie Jean McKinley, and the couple's blessed union produced two children, Randall Clemons and Barry Clemons; he is the proud grandfather of Michael Clemons, Ashley Clemons Jordan, Steven Clemons, and Skyler Tucker Cowan and the doting great-grandfather of Kolby Jordan and Raelynn Cowan; and

WHEREAS, as Mr. Clemons approaches his tenth decade, he is still an active and productive member of his community; he has been a member of the Carthage Benevolent Lodge No. 14 since 1957 and the Smith County Shrine Club, of which he has served as ambassador and chairman of the Smith County Shrine Paper Sale, since 1974. He was instrumental in the founding of Granville Museum, where he is a docent, and he currently works as a guide at Sutton Homestead Pioneer Village; and
