WHEREAS, this year's Social Work Month theme, "Elevate Social Work," embodies the need to recognize the extraordinary contributions of the social work profession; and

WHEREAS, social workers elevate and empower people, giving them the ability to solve problems, cope with personal roadblocks, and get the resources they need to succeed; and

WHEREAS, social workers can be found across Tennessee working in government, schools, universities, social service agencies, communities, corporations, the military, and a variety of medical and mental health settings; and

WHEREAS, over fifteen public and private universities provide accredited social work education programs at the baccalaureate, master, and doctoral level in Tennessee; and

WHEREAS, social workers are the largest group of licensed mental health providers in the State of Tennessee; and

WHEREAS, social workers travel across the nation and world to aid people in crisis, helping them overcome issues such as death and grief, epidemics, and natural disasters such as wildfires, hurricanes, and floods; and

WHEREAS, the social work profession, for more than a century, has been helping to create changes to make our communities better places in which to live; and


WHEREAS, over 500 social work students, faculty, and professionals from across Tennessee will gather on March 27, 2019, in Nashville for Social Work Day on the Hill; now, therefore,
