WHEREAS, as a New York University pediatric dental resident, Dr. Akbari is currently gaining invaluable clinical and didactic experience in areas including pediatric oral sedation, treatment under general anesthesia, behavior management, and orthodontics under the guidance of board certified pediatric dentists and orthodontists; and

WHEREAS, in everything he does, Dr. Alexander Akbari exhibits a strong work ethic; he is committed to long-term success and has been empowered and motivated by his distinctive experiences, commitment to service and community, and relationships with underserved populations; and

WHEREAS, Dr. Akbari is a professional and public-spirited individual of the highest order, and he is poised to make significant contributions in his hometown of Nashville as a board certified pediatric dentist; now, therefore,
