WHEREAS, Chief Scott Robbins exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout his estimable career, Chief Robbins has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of his colleagues and a grateful public; now, therefore,

BE IT RESOLVED BY THE SENATE OF THE ONE HUNDRED ELEVENTH GENERAL ASSEMBLY OF THE STATE OF TENNESSEE, THE HOUSE OF REPRESENTATIVES CONCURRING, that we extend to Chief Scott Robbins our heartfelt wishes for a happy and fulfilling retirement and every continued success in his future endeavors.
