A RESOLUTION to honor the memory of Peggy Williams Daniel of Selmer.

WHEREAS, we were greatly saddened to learn of the passing of Peggy Williams Daniel; and

WHEREAS, born in Humboldt to Jewel White Williams and Oscar Reggie Williams, Sr., Peggy Daniel was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens in numerous capacities; and

WHEREAS, a graduate of Jackson High School, she attended the University of Tennessee at Martin and obtained her Bachelor of Arts degree from Lambuth College and her Master of Education degree from Memphis State University; and

WHEREAS, Mrs. Daniel served with acumen and alacrity as an educator for nearly three decades, earning the respect of her peers, superiors, and students alike for the exemplary quality of her work; she taught kindergarten for nine years before serving for twenty years as the Gifted Coordinator at TACS for the McNairy County school system; and

WHEREAS, active in her community, she served on the board of a number of worthy organizations, including the Nat T. Williams Developmental Center, the Reelfoot Girl Scout Council, the McNairy County Election Commission, the Tennessee Arts Commission, the McNairy County Library Board, and the Shiloh Regional Library Board; she served as Chairman of Arts in McNairy; and

WHEREAS, generous of spirit, Peggy Daniel served as a Girl Scout leader and a Cub Scout leader, and she dedicated her time to Team Read, Arts in McNairy, the Stephen Foster Music Club, the McNairy County Young Republicans, Republican Women, and the Republican Executive Committee; and

WHEREAS, throughout her estimable lifetime, Mrs. Daniel won a number of awards, including the Selmer Jaycees Outstanding Woman of the Year, Rotary Club Citizen of the Year, and the Distinguished Service Award from the McNairy County Young Republicans, Republican Women, and Republican Party; she received the Tennessee 7th Congressional Statesman of the Year Award, which brought tremendous pride to herself, her family, and her friends; and
