WHEREAS, prior to her employment with UTMC, Janell Cecil served as a system service line administrator for Women and Children's Services for Baptist Memorial Healthcare Corporation in Memphis from 1995 to 2002; and

WHEREAS, her previous employment also includes tenures with Saint Luke's Hospital in Kansas City, Missouri, as a specialty line manager, clinical director, assistant patient care manager, and clinical nurse; and

WHEREAS, Janell Cecil received her Bachelor of Science degree in Nursing from Webster University in 1984 and her Master of Science degree in Nursing from the University of Missouri in 1997; and

WHEREAS, she is a member of the American Nurses Association, the American Organization of Nurse Leaders, the Tennessee Organization of Nurse Executives, the East Tennessee Healthcare Executives Association, and Sigma Theta Tau; and

WHEREAS, appointed to the Tennessee State Board of Nursing in 2017, Janell Cecil is an Honors Member of the Nightingale Society, a 2012 graduate of Leadership Knoxville, and a member of the University of Tennessee, Knoxville College of Nursing Advisory Council and the Nursing Board of Visitors of Tennessee Wesleyan College/Fort Sanders; and

WHEREAS, no stranger to awards and accolades, Janell Cecil has received the Health Care Heroes Award, the Tennessee Hospital Association Nurse of Distinction Award, the Volunteer Nurse Champion Award, and the TONE – Excellence in Nursing Leadership Award; and

WHEREAS, Janell Cecil exemplifies the spirit and allegiance to family and community that are characteristic of a true Tennessean; and

WHEREAS, throughout her estimable career, Janell Cecil demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of her colleagues; now, therefore,
