WHEREAS, a retired public servant, Doug Buckles was an employee of the Johnson City Fire Department for thirty years, holding the esteemed position of Fire Chief for the entire city during the last eleven-and-one-half years of his tenure, and served as president of the Southeastern Chiefs Association; and

WHEREAS, Doug Buckles was a member of the Elizabethton Elk Lodge, the Veterans of Foreign Wars Post 2166, the American Legion, and the Moose Lodge; and

WHEREAS, he was a faithful member of Carter Christian Church, which he served in numerous capacities over the years; and

WHEREAS, Mr. Buckles was preceded in death by his parents; his brother, Augusta Buckles; and his sister, Virginia Clark; and

WHEREAS, devoted to his family, Doug Buckles is survived by his beloved wife, Carolyn Perrett Buckles; three children, Leigh Anne (Darrin) Rowe, Douglas Wayne Buckles, Jr., and Chad Dwayne Buckles; three grandchildren, Logan (Tabatha) Rowe, Colton Rowe, and Addisyn Rowe; two great-grandchildren, Arianna Mitchell and Emily Shelton; one sister, Voretta (Phil) French; two brothers-in-law, Paul (Diane) Perrett and Bubba (Sherry) Perrett; and several nieces and nephews; and
