A RESOLUTION to honor the memory of Judge John K. Wilson of Greeneville.

WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of Judge John K. Wilson; and

WHEREAS, a retired circuit court judge, John Wilson was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for his fellow citizens in numerous capacities; and

WHEREAS, Judge John Wilson served with distinction as a member of the United States Air Force and as an assistant district attorney under Heiskell Winstead for eight years; and

WHEREAS, in 1979, Governor Lamar Alexander appointed Judge Wilson to the bench as the circuit court judge for Greene, Hamblen, Hawkins, and Hancock counties, in which capacity he served for thirty-five years until his retirement; and

WHEREAS, Judge John Wilson was an important part of his community who served on the Nolachuckey Mental Health Board; and

WHEREAS, a man of devout religious faith, Judge Wilson was a member of First Baptist Church and Gideons International; and

WHEREAS, he was also deeply devoted to his family, and he always endeavored to remain true to family values of the highest order; and

WHEREAS, Judge John Wilson enjoyed the loving companionship of his wife of fifty-three years, Nancy Wilson; he was the proud father of Kimberly Wilson (Scott) Carter and John Waggoner (Heather) Wilson, and the devoted grandfather of Charlotte Grace Carter, Victoria Carter, Miranda Wilson, Sara Wilson, and Emma Wilson; and

WHEREAS, he is lovingly remembered by his mother, Ethel Cates Wilson; his brothers, Richard Wilson and Jerry (Donna) Wilson; his sister, Margaret (Ted) Pate; his brothers-in-law and sisters-in-law, Joe and Diane Waggoner, Harold and Ellen Waggoner, and Margaret Wilson; and a host of extended family and dear friends; and

WHEREAS, Judge Wilson was preceded in death by his father, Albert Wilson; his brother, James Wilson; and his parents-in-law, Burnice and Margaret Waggoner; and
