WHEREAS, a lifelong resident of Cleveland, Mr. McKenzie was a graduate of Cleveland High School and a member of the Church of God by faith; and

Murray, Kiersten (Andrey) Belyy, and Miranda Goff, and he was eagerly awaiting the birth of his great-granddaughter, Esther Belyy; and


BE IT FURTHER RESOLVED, that we express our sympathy and offer our condolences to the family of Mr. McKenzie.
