WHEREAS, in addition to having earned a Master of Business Administration degree, Heather Duncan is a graduate of the UT Local Government Leadership Program, holds a certificate from the Leadership Institute in Judicial Education, and is a UT Certified Public Administrator; and

WHEREAS, she has given back to her community as a coach for various youth sports teams, an officer in various parent-teacher organizations, and a Sunday School teacher; and

WHEREAS, Heather Hinds Duncan is most grateful for the love and companionship she shares with her husband, John Duncan, and her four children; and

WHEREAS, Ms. Duncan has set an example as an elected official that both her peers and future officeholders would do well to emulate, and she should be recognized on this special occasion; now, therefore,
