A RESOLUTION to honor the memory of Linda Faye Hall of Memphis.

WHEREAS, the members of this General Assembly were greatly saddened to learn of the passing of Linda Faye Hall; and

WHEREAS, Linda Hall was an exemplary public servant and consummate professional who worked assiduously to improve the quality of life for her fellow citizens in numerous capacities; and

WHEREAS, born on May 23, 1959, Ms. Hall was the daughter of James and Lucille Hall; she was a 1977 graduate of Manassas High School and went on to attend the University of Tennessee, Knoxville, where she majored in pre-medicine; and

WHEREAS, Linda Hall worked in the medical field before joining the United States Air Force, from which she was honorably discharged in 1989; a founding member of the Black Aircraft Mechanics Association, she worked for FedEx for nearly thirty years as an aircraft mechanic. She was promoted to aircraft maintenance manager, in which position she worked until she fell ill; and

WHEREAS, a college classmate of and best friend to Representative Karen Camper, Ms. Hall was heavily involved in community service and volunteered with a host of organizations; she served as a Girl Scout leader with her childhood best friend, Jackie Jones, and as a basketball coach, and she distributed toys for Toys for Tots and attended school plays, baseball games, and choir engagements; and

WHEREAS, she also served as a mentor for her family, close friends, and community, embracing children from less fortunate families and inviting them to join her family vacations; and

WHEREAS, Linda Hall was a devout woman of Christian faith; she professed her faith in God at an early age at Coleman Chapel C.M.E. Church; and

WHEREAS, Ms. Hall will be fondly remembered for her love for cooking, books, music, and plants; she was also an avid traveler and shopper who loved sports and tailgating at the Southern Heritage Classic; and

WHEREAS, Linda Hall was deeply devoted to her family, and she always endeavored to remain true to family values of the highest order; and

WHEREAS, she was preceded in death by her parents and her brothers, Michael Hall and Bobbie Tate; and

WHEREAS, she is survived by her brother, Robert (Faye) Hall, Sr.; goddaughter, Latricia Conley; nieces, Chennel (Ronald) Tate, Angela Tate, and Bobbie (Toby) Tate; nephews, Tyrone Hall, Robert (Leticia) Hall, Jr., and Mario (Machelle) Biggs; great-nieces and -nephews, Vicki (Kevin), Camilla, Rondarrius, Mariah, Mason, Lakeiron, Malia, and Grayson; and a host of extended family members; and
